1. DEFINITIONS

- 1.1. **"Personal Information"** means all information relating to an identifiable, living, natural person and, where applicable, identifiable, existing juristic person, as defined in the POPI;
- 1.2. **"POPI"** means the Protection of Personal Information Act 4 of 2013;
- 1.3. **"Processing"** means the creation, generation, communication, storage and destruction of personal information as defined in the POPI;
- 1.4. **"Quantum Foods"** means Quantum Foods (Pty) Ltd (registration number 2012/124966/07) and all of its brands including but not limited to, Nova Feeds and Nulaid;
- 1.5. **"You"** means any person accessing and browsing the Website, and **"Your"** shall have a corresponding meaning thereto; and
- 1.6. **"Website"** means Quantum Foods website accessible at www.quantumfoods.co.za, Nova Feeds website accessible at www.novafeeds.co.za and Nulaid's website accessible at www.nulaid.co.za.

- 2.2. This Privacy Policy governs the Processing of Personal Information through Your use of the Website with effect from 1 April 2020.
- 2.3. Quantum Foods hereby reserves its right to amend this Privacy Policy as and when required and it is Your responsibility to be appraised of the current version of this Privacy Policy.

3. PROCESSING AND RETENTION OF PERSONAL INFORMATION

- 3.1. By providing Your Personal Information to Quantum Foods through the use of the Website, You acknowledge that it has been collected directly from You and consent to the Processing thereof by Quantum Foods.
- 3.2. Personal Information collected from You through the use of the Website shall only be used for the purpose for which it was submitted or such secondary use related to the primary use, unless provided otherwise at the time of collection.
- 3.3. Quantum Foods will only Process Personal Information in a manner that is adequate, relevant and not excessive in the context of the purpose for which it is Processed and in accordance with the POPI and/or any other applicable legislation in South Africa, unless You agreed otherwise.
- 3.4. Quantum Foods agrees to Process your Personal Information in connection with its business only.
- 3.5. Quantum Foods shall keep records of all Personal Information collected and the purpose thereof for a period of 1 (one) year from the date on which it was last used; and will not disclose any Personal Information unless Your prior written agreement was obtained or Quantum Foods is required to do so by law.
- 3.6. Quantum Foods will destroy or delete any Personal Information that is no longer needed by it for the purpose initially collected, or subsequently Processed.

4. SECURITY

Quantum Foods strives to ensure the integrity, security and privacy of Your Personal Information whilst accessing the Website and we review our security measures regularly. Notwithstanding the aforementioned, Quantum Foods cannot be held liable for any loss or other damage sustained by You as a result of unlawful access to or dissemination of any Personal Information by a third party. 5. COLLECTION OF ANONYMOUS DATA FOR STATISTICAL USE
